**Orchestrate Legal-Stream** is a Hybrid, Cloud based, and/or On-Premise based system that streamlines the recording process. **Legal-Stream's** easy functionality and simplified user interface takes control of the recording process with a single tap - no need to deal with the extra overhead associated with outdated systems.
